## **Report of Conspiracy to Commit Fraud and Extortion**

**CASE:**

Stephen Russell Conspiracy to commit Fraud and Extorsion Investigation -Supplemental Report on backgrounds and biographical information on suspects, and witness included.

**SCOPE:**

On or about February 1<sup>st</sup> of 2018 the victim entered into contract with a company owned and operated by (S-2) Maman at the direction of (S-1) Akkelquist. (S-2) Maman subcontracted protection work to (S-3) Timen and (S-4) Shlomo. The suspects conspired to commit fraud by gaining the victims trust using false pretenses in that they had high level government contacts in the intelligence community of the United States, Israel, Russia and the Ukraine.

The suspects, fabricated information they stated was actual intelligence from their supposed high-level government contacts and advised the victim that his life was in imminent peril. The suspects acted together in a coordinated manner creating constant fear in the mind of the client while continuing to escalate the victim's perceived threats against his safety and life. The suspects then coerced him into agreeing to pay for highly suspect and questionable protection and intelligence information while the subject was under duress directly attributed to the suspects terrorizing scheme to extort money from him. The suspects conspired to defraud him of money by falsely stating and charging the victim for protection agents that the suspects never actually provided. This was corroborated by (S-3) Timen after a quarrel between the suspect brought pertinent information to light.

**Narrative:**

Mr. Russell is a technology entrepreneur and Silicon Valley veteran with more than 20 years of experience in building and managing disruptive video search, biometrics and artificial intelligence technology companies. He is the CEO and Founder of Prism Skylabs, a retail video intelligence platform.

Prior to Prism Skylab, Mr. Russell served as the CEO and Chairman of 3VR, the world's leading video intelligence company, which he founded in 2002. 3VR was partially funded by "In-Q-Tel" the CIA venture fund. Some of his notable international facial recognition projects include pilots and deployments in the Moscow Russia Subway, the Seoul Korea Subway, and Singapore's National Airport.

Mr. Russell had a Security Clearance through the FBI and on occasion consulted with various United States intelligence agencies during his tenure with 3VR. More recently, he was informed by the US government that both his FBI file and the details of his consulting work had been obtained by other foreign governments during the US Office of Personnel Management breach and the larger Edward Snowden leak.

Mr. Russell is an active investor with notable companies including Ring (now Amazon) OpenDNS (now Cisco Security) and Uber, as well as, several other security and technology companies. He holds 13 patents mostly related to computer vision, biometrics, artificial intelligence and security devices.

Most recently, in late 2016 and early 2017, Mr. Russell, along with Ring CEO Jamie Siminoff, set up one of the largest artificial intelligence research and development offices in Kiev Ukraine.

Upon (V) Russell's return to the United States from a trip to Ukraine in late 2016, he began noticing suspicious subjects and circumstances in and around his home, work and during various outings. Subjects were noted to be following, surveilling, and possibly entering the victim's home. There were indications of his home network/WIFI being hacked as well as computer equipment and security cameras being tampered with. One Private Investigator reported being followed by unknown subjects. Russell attempted to get assistance from his

government contacts at that time, but no clear understanding or resolution of the circumstances was reached.

In late 2017, Thomas LaFreniere and his company, DynaSec, was hired to conduct an investigation into this matter and provide protective services. During this time a suspected device was seized from Russell's home which appeared to be a covert camera or other specialized device concealed in an electrical outlet. The outlet was ultimately sent to (W) Ryan Micheletti of Shield Corps Security for analysis. Ryan forwarded a video of the device to (S) Akkelquist who made a determination from the video that the device was Russian or Russian mob-related.

(W) Micheletti, then sub-contracted this case to (S) George Akkelquist and (S) Nir Maman (both unlicensed in CA with BSIS to perform security work). The referral was made due their confident assessment of the device to the suspects' claimed previous employment and contacts with various governmental entities in the intelligence community. (S) Akkelquist claimed to have worked for the FBI, CIA, Mossad and said to be currently working with the IDF and other agencies. (S) Nir Maman claimed similar associations but with emphasis on connections with the Mossad.

Later, both suspects claimed to independently verify that there were active threats against Stephen (V) Russell. They provided the victim with specific and apparent credible details related to a business deal of (V) Russell's company in Russia and also the Ukraine.

(V) Russell was also provided photos, recordings, and other pertinent information relating to his perceived threat. On multiple occasions, the suspects relayed convincing "intelligence" information which served to dramatically increase the victims concern for his safety. The suspect began to isolate him from anyone who had helped him in the past and was instructed not trust anyone except them including representatives of the US Government. They explained to him that some of his former security team, as well, were most likely part of the opposing entity that attempted to harm him.

The suspects then escalated the perceived threat by providing compelling information they had allegedly discovered using their connections with the Russian intelligence community. One example was telling the (V) Russell that a specific, known, Russian mob boss also known as the CEO of Galfort, a Russian security company, had put a contract out on the victim's life and/or a request to steal/acquire the victim's intellectual property (IP). They alleged that was due to the victim pulling out of a 3VR biometric pilot project in the Moscow subway system. (S) Akkelquist told the victim the CIA had initiated a counter

intelligence investigation into the victim and his association with the Russian government and the investigation was still active. (S) Akkelquist further stated the CIA was responsible for the recent mass cancelling of all of Prism's retail analytics contracts in Russia. Akkelquist also told (V) Russell that Prism's President, Joseph Saad, was attempting to takeover Prism and (V) Russell's babies, grandfather, Steve Walsh (father of Tara Walsh) and their family were scheming to take his child that he shares with Tara Walsh (estranged girlfriend, mother of child Evie in common). This was designed to cause Mr. Russell, the victim, to believe his life was in immanent peril. Under duress, and fear for his life, (V) Russell agreed to pay the suspects \$200,000 per month for a security team and protection services. The agreement was for a team consisting of approximately two to four, former Mossad agents, or individuals with similar experience and qualifications. The including a remote investigative team and other "unseen" members of the protective detail. (See attached "Agreement of Service" dated 04 12 18 below)

(S) Timen was sub contracted to as the team leader of the protection team for (V) Russell. (S) Timen advised the victim that he had four people covering the victim at all times, wherever he went and that even if he didn't see them to trust him, they were there watching over him. (S) Timen later admitted to the victim that this was a lie and he had been instructed by the (S) Akkelquist and (S) Maman to convince the victim he was being protected twenty-four hours a day even if he didn't see anyone visibly protecting him. In fact, (S) Timen and (S) Shlomo who was part of the protection team, rented a distant hotel in which to use for a base of operations instead of the vacant apartment supplied to them by the victim so that he could have close protection. The victim even put (S) Timen and (S) Shlomo on the lease agreement, but they refused to use the supplied apartment. This is further evidence of their lack of intent to provide reasonable protective services.

In March of 2018, (S) Akkelquist and (S) Maman demanded that for his own safety, the victim had to leave his home and go to a safe location in Hawaii. Once in Hawaii they Stayed at what they were told was (S) Akkelquist house. (S) Akkelquist (S) Maman and (S) Timen continued to manipulate and instill fear in the victim by telling him that they had received intelligence that various unknown foreign entities were plotting to harm him. (S) Akkelquist attempted to persuade (V) Russell to believe the solution to his safety and security problems was to partner with (S) Akkelquist and provide the victim's company (Prism Skylabs) intellectual property to (S) Akkelquist's company. His company "Vallation Security" according to (S) Akkelquist said was providing services for clients ranging from the FBI and other foreign governments. (S) Akkelquist also took (V) Russell to his "wife"

“Valerie”, a naturopath on the island, who attempted to sell him cookware, nutritional shakes, and CBD products.

### **EMERGENCY MOVE**

Upon returning to San Francisco, (S) Akkelquist and (S) Maman orchestrated an emergency move of (S) Russell and his then girlfriend and their new born baby to Redwood City. This emergency move was supposedly required due to an “imminent threat” where (S) Maman and (S) Akkelquist then suggested (V) Russell increase his security detail and engage in a multi-million dollar “cyber operation” facilitated by “Israel” via (S) Maman’s father in-law who was a supposed active member of the Mossad. The suspects acted in a calculating and manipulative manner by instilling fear in order to create a mental state of mind of impending doom to facilitate the victim to pay more money with no real intent of providing any type of reasonable service as agreed.

Repeating this pattern, (S) Akkelquist and (S) Maman insisted that (V) Russell from his home in which was fully paid for, due to “credible threats” they said existed. (V) Russell moved to a “secure” apartment building at 301 Mission Street in San Francisco CA only to see a dramatic increase in odd events and attributed “threats.” It was here that (V) Russell was given a “contract” to sign for additional security services and his financial advisor was given a second invoice for cyber investigative services later claimed to be a “contract” as well.

During the course of their supposed services (V) Russell continually asked for proof beyond the suspects verbal assurances and vague inferences, that in reality someone actually wanted to harm him but to this date no paperwork or other documentation has been provided. Upon being notified of the invoice “contract” terms by his investment manager and having (S) Timen and (S) Shlomo of his protective detail admit to certain other lies and

fraudulent inconsistencies, (V) Russell realized that he was likely a victim of a fraud and cancelled his contracts for breach and requested the return of any outstanding funds held by (S) Maman and (S) Akkelquist.

The suspects both refused, made veiled threats, and even demanded the victim continue to pay them an additional four million dollars. Later, (V) Russell received a text message from (S) Akkelquist suggesting that the “security of his family was no joke” and (S) Maman’s attorney sent a letter (see attached) that included strongly defamatory statements known by

(S) Maman to be exaggerations and lies but were intended to coerce him into continuing to pay money or fear being exposed for the lies and exaggerations outlined in the document prepared by (S) Maman's attorney which was, specifically crafted to extort money from the victim.

**The following is an excerpt from a note sent to (V) Russell by (S)Maman, which the victim believed was a direct threat directly against he and his family:**

“There are no unused funds Steve. Everything that has been paid out so far was put towards all your requested services. Further, you are actually in arrears.

1. You agreed to a 3-million-dollar intelligence and investigative package, with 1 million as a down payment to commence the work and 2 million guaranteed against your Uber shares paid out in 1.5 years,
2. There is an outstanding invoice for 4 weeks of service, you need to authorize the release of that payment immediately Steve as I had to pay all my guys.
3. You signed an agreement committing to a full year of service at \$200,000 per month. I can resend you that agreement if you would like to see it.

**Lastly, I'm telling you this right now Steve, you are driving yourself to the ground, you're making all the wrong moves right now, you are walking yourself into the lion's den.** If you want us to walk away for good, that's not a problem we can do that.

You'll need a final report from us to document the last three months plus everything we factually found for you. If you would like us to produce a report **to your liking, You need to do good on all of your agreements, or we can negotiate a resolution if you would like. But I'm telling you for the sake of your family you need to get a grip on yourself.**”

The victim believes that this message was a meant to threaten him to pay the money for services not provided and that failure to do so would result in his family's safety being put at risk. Furthermore, that the suspects would fabricate and disseminate derogatory and or damaging information about him which would be intended to discredit and or ruin his good name and reputation in the technology world.

At this point (V) Russell is seeking the return of his money and desires to make sure that no other individuals are victimized in the same way. Our own investigation into (S) Maman and (S) Akkelquist would seem to indicate a pattern of behavior as unlicensed security advisors conspiring to defraud and extort significant sums of money from their clients. They had said money wired across state lines into Canada. We have also confirmed the use of multiple identities, a false social security number, multiple shell companies, and a pattern of lies and deception relating to their backgrounds and associations. Given the large amount of money directly defrauded, the incalculable costs to (S) Russell's finances, family, business, as well as the direct attempts to exploit past associations and tarnish the reputation of the FBI, we believe this case deserves the highest level of attention even without regard to the potential involvement of a foreign government.

#### **EVIDENCE AND DOCUMENTATION:**

***Suspicious circumstances and tampering upon return from Russia and Ukraine;*** In a letter addressed to Stephen Russell dated June 5<sup>th</sup> 2018, (W) Ryan Micheletti, CEO of Shield Corps Security Inc. affirmed suspicious activity occurring in the following excerpts;

*When you and I first met in October 2017, you described the security situation as a series of covert actions being taken against you, including possible surveillance and drug dosing's. In the following months, it became evident that this was true and that these strange occurrences could have been tied to previous business relationships in an effort to discredit you as one of the world's leading experts on computer vision and biometrics.*

*In early February 2018, after the new security detail with CT 707 was established, you and I met in New Jersey with George and Nir to discuss the overall security situation and the relevant background information. Based upon your documentation, the videos and pictures of potential surveillance devices, it became self-evident that there were a series of concerning events and circumstances which indicated a likely security threat that attempted to discredit you personally and professionally. There were several reported suspicious activities and occurrences documented by you and others prior to the start of the security detail, including:*

*Individuals caught on camera walking in front of your house with a device on their nose that projected IR shadows and light to blur their face.*

*Covert surveillance devices found in your home.*




*I am in receipt of the letter provided you by Nir Maman's attorney William Capps. I was shocked and angered by the letter and would like to distance myself and my firm from its claims in the strongest possible terms.*

*For background, my company Shield Corps made the introduction of Nir Maman and George Akklequist to Stephen Russell. I was present for most of the significant meetings described, the presentation of the proposals in question, as well as, the trip to Hawaii and other interactions described in the letter. I am also the listed "witness" to these agreements. And I was the primary keeper of notes on all interactions between the security team and Mr. Russell.*

*Since I am not an investigation professional, I deferred to George and Nir's expertise and theory that the most likely sources of these security issues were related to his previous professional relationships with international organizations as well as with his past business dealings with government agencies within the United States. George Akkelquist led the overall project with Nir Maman being tasked with primary responsibility for Mr. Russell's protection and parts of our investigation.*

Hi Steve,

I am writing this letter to provide an overview of the relationship between Shield Corps Security and CT 707, as well as to provide my perspective of the security situation that has occurred over the last several months.

When you and I first met in October 2017, you described the security situation as a series of covert actions being taken against you, including possible surveillance and drug dosing's. In the following months, it became evident that this was true and that these strange occurrences could have been tied to previous business relationships in an effort to discredit you as one of the world's leading experts on computer vision and biometrics.

Since my company, Shield Corps Security, does not specialize in investigative services, I introduced you to Dynasec International, led by Tom LaFreniere, which is a well-regarded security company that specializes in private investigations. I did not charge you for the referral as it was based upon our mutual friendship and a desire to help you uncover the nature of the threats against you.

Several months later, in January 2018, I contacted you to check in and see if there were any positive developments. Based upon our conversation, it appeared that the situation was not progressing and that you were seeking alternatives. George's extensive experience gave me confidence that he could help the situation. Later, you retained George directly as an advisor to help navigate the complex security situation.

During the time I was with you, I observed that you behaved normally, went to work, had business meetings, looked for an apartment and was concerned about Tara and your baby's arrival.

The information and concerns I received regarding you, came from Nir and George, while they were away and not in any proximity to the security detail or you.

The behavior described in Nir's letter is not information deriving from any reports I sent to Nir or his team. During my work with you, I did not see you use drugs or suffer form mental illness.
