1 Having considered Plaintiff and Cross-Defendant Stephen Russell's Motion to Compel
2 Defendant and Cross-Complainant Tara Walsh to Sign Authorizations to Release Medical,
3 Psychological, and Educational Records and for Sanctions, and the related opposition and reply papers
4 and argument of counsel and Defendant Walsh, the Court hereby **GRANTS** the motion with respect to
5 the eleven authorization forms only. Within ten calendar days of entry of this Order, Walsh shall sign

10 will impose as a sanction for disobeying this Court's Order, the dismissal of her Cross-Complaint with
11 prejudice, That part of the Court's previous Order of September 8, 2020 ordering an Independent Mental
12 Examination of Ms. Walsh to be conducted on October 26 & 27, 2020 is hereby vacated..
