


**Exhibit D-1 "I Need Help With Evie"**


**Exhibit D-2 "You Can Visit Whenever You Want"**



T: You can come visit Evie whenever you want Steve.


S: I agree to that. I can visit whenever I want. Where is Evie?

T: I want that too but I'm honestly afraid that if you see her again you are going to start court actions again. I cannot afford round two of that - financially, mentally, physically.


Can you do something to assure me that you will not file court actions?



**Exhibit D-5 “DL and Passport are Already Suspended. Hearing Same Day Petition”**




T: Also the support collection called me and your license and passport likely are already suspended.

S: Who is this?


T: Omg you need help

T: Btw are you saving for Evie's college? Or anything having to do with her? I have tremendous financial pressure


S: My family dn have much but we can help take care of Evie.

**Exhibit D-8 “Imagine What that Does to Her”**




T: I had to tell her last night you were trying to take our home. Imagine what that does to her.

**Exhibit D-9 “Evie will Suffer”**




T: Yes you paying child support and not making my life harder than it is. I hope you realize if you pay less support her life will suffer.
