Dear Lydia:

You are making excuse after excuse for your client in furtherance of her efforts to hinder Steve's right to see his daughter. Both last night and this morning, Tara has reneged on her own prior proposal and changed her position several times. It is unbelievable that now, after we have reached an agreement, you are claiming that Tara cannot sign until after 4:00 p.m. today and that she no longer agrees to Abby supervising the visits, as this effectively prevents Steve from seeing Evie for the entire weekend, since even if Tara signs at 4:00p.m., it is nearly certain that the Stipulation will not be So Ordered before Monday. Enough is enough with these stalling tactics.

Also, in response to your email this afternoon objecting to Abby, I see no reason why Abby cannot supervise the visits today and for the next three (3) days so that Steve can see Evie before he has to return to California. Last Friday, I informed you that Abby would be coming to NY with Steve to supervise the visits and Tara had no objection until now. Moreover, Tara has not made any claim in this case or in California that raises concerns about Abby or claims that Abby is unfit to serve as the temporary supervisor. Also, Ms. Jackman met with Abby yesterday and supports Abby being present for the visits. Your client's objection to Abby is therefore baseless and unreasonable.

We all agree that the current order must be modified because Tara's father and family are unwilling to supervise visits. Yesterday, Tara's attorney in California advised us that Tara's father will not supervise the visits and so Steve should contact Tara's mother. However, when Steve reached out to Tara's mother to see Evie, Tara's father sent my office an aggressive and accusatory email claiming that Steve is harassing Tara's mother. It has been five days since Steve traveled to NY from California with his nanny solely to see Evie and he still has not seen her or spent even one minute with her. It is a tragedy that he now may not see her before he has to return to California next week. Tara's family has also ignored each of Steve's requests to see pictures of Evie and Facetime with her over the past several weeks.

**Statement by Abby Tedla and Kelly Turnure:** Steve couldn't wait to see Evie. Steve and Abby met the Walshes and Evie in the parking lot of the Crabtree Kittle house. Maura Walsh was very uncomfortable and looked like she had been crying. She did not initially want to hand Evie over to Steve, so he suggested that they all sit for a moment in the hotel's lovely outdoor seating area. After about 15-20 minutes Steve Russell and Mr. Walsh were able to convince Maura Walsh to hand Evie over to Abby Tedla, Evie's childhood nanny. Maura Walsh began to cry and shake as she handed Evie to Abby and Evie began to cry, as well. Steve and Abby quickly walked to their hotel room where Abby handed Evie to Steve. In his arms she calmed down quickly and he spent the rest of the visit holding her. After she was calmed down and happy Steve sang her songs and talked to her for about 45 minutes.




I spoke to Evie's care provider and went through her chart and even spoke to the RN who was primarily responsible for Evie's sole visit yesterday. There has been no follow up.

Evie had no fever, no signs of illness, no signs of dehydration. She was alert, happy, and active. Tara was not present at the apt, Evie was prescribed a probiotic and fluids, despite the absence of dehydration.

The note was provided without much thought, and by simply providing fluids and a probiotic pack once a day, my visit would not have been an issue.

Grandma said that Evie was having diarrhea 5 times a day. The diagnosis of a viral infection was made purely based on Grandma's statement and the absence of any obvious symptoms...sometimes a viral infection of the gut bacteria specifically can cause asymptomatic diarrhea but no direct signs of this were noted. It was a diagnosis of exclusion.

It is likely true that Tara and Grandma are simply lying or exaggerating a relatively benign situation to avoid visits, but a much more serious possibility exists.

Tara drugged me. Her mom's behavior with Tara as a child is consistent with Munchausen by Proxy and the previous supervisors noted strange rashes and the fact that Evie had not napped or eaten as causes for grumpiness at previous visits. Tara is a BPD w/ sociopathic traits according to her Doctor in SF and my understanding is that her mind works differently than a normal person especially when she feels cornered.

We would be negligent to ignore the very real possibility that Tara gave Evie a diuretic or engaged in some other activity she saw as only lightly or temporarily harmful to Evie, but she rationalized as being necessary to deny visits. That is how she rationalized drugging me.

My daughter's health is my first priority.

During my time acting as nanny on March 30th, I observed a raised, red and clearly irritated rash on Evie's chin, hidden in her baby fat. Otherwise she seemed to be perfectly fine aside from having a ravenous hunger for the food we had for her. Both myself and the supervisor both noticed and discussed the rash and her hunger. On March 31st I acted as Nanny again and that day I observed a bruise on Evie's left shin as Steve was changing her diaper. The day before I did not see a bruise as he changed her but on March 31st it was very visible. The Supervisor made a note of it and said she had to make a report for it. Steve mentioned he would follow-up and give her a bath the next time to check for any other areas. On March 31st she had the same ravenous hunger but the rash was less noticeable than it was the day before.

At the drop off of Evie I witnessed Steve Walsh pull up at the top of the driveway after the supervisor headed toward the house with Evie, so the supervisor was not there to see this. Steve Walsh exited his car and had a rude attitude toward Steve and proceeded to say that he was "bringing his kids back home from school" on Sunday March 31st at approximately 5:30. Steve Russell did not respond and simply sat in the car to wait for the supervisor to return. Once the supervisor returned she asked if that was Tara's father behind us and Steve Russell confirmed and we drove off the property. Steve Russell remained calm throughout the entire interaction with Steve Walsh.



Dear Counsel:

My client advises that the Chappaqua police came to her house yesterday evening. Apparently, Mr. Russell filed a police report yesterday claiming that their daughter was being abused. 



