I. BACKGROUND

Drexel has pleaded guilty to criminal charges, entered into a consent decree with the Securities and Exchange Commission, and has had numerous claims and lawsuits filed against it based on charges of employee misconduct. DBL Group, DBL Inc., and seventeen of their affiliates have cases pursuant to Chapter 11 of the Bankruptcy Code pending in the Bankruptcy Court for the Southern District of New York. These Chapter 11 cases have been consolidated for procedural purposes under case number 90 B 10421 before Bankruptcy Judge Conrad. In *In re The Drexel Burnham Lambert Group., et al.*, No. 90 Civ. 6954 (MP), Chapter 11 Case No. 90 B 10421 (FGC), Judge Milton Pollack entered an order on February 19, 1991, which withdraws the reference of the Drexel Bankruptcy case to the Bankruptcy Court, "re-refers" the core portions of the Drexel Bankruptcy case to Bankruptcy Judge Conrad, and orders that the non-referred portions of the Drexel Bankruptcy case now be administered jointly by Judge Pollack and Bankruptcy Judge Conrad.

This action is a state-law declaratory judgment action and breach of contract suit commenced by Drexel in the New York State Supreme Court against forty defendant insurance companies who provided Drexel with insurance coverage under various "fidelity bond" insurance policies during the years 1986 to the present. Plaintiffs seek a declaration of its rights under those policies, together with not less than \$140,000,000 in damages based on defendants' refusal to pay certain claims under those bonds. This action was removed by three of the forty

Then, like an idiot, I started hysterically crying. Once I started crying, I couldn't stop. It had nothing to do with the situation. It had to do with the private wound that exists inside of me suddenly opening up, and spilling out without me being able to control it.

Stress about doing well at school, and being the best at everything I tried, and more than anything, modifying my behavior as to keep the abusive situation at home under control, which meant trying to make my mother happy. I never talk about my childhood being "abusive," which it was. Outside of the house, I tried to be perfect, but inside, I was always being punished.



Some people I have talked to about this say, "So what, you're a good mother, nothing will happen to you." The thing is, back when I was 18 years old, and a sophomore in college, my sister, who had just escaped from a boarding school, and was suing my parents for emancipation, called Child Protective Services on my parents and myself over 35 times. I was 18, and could have technically been given custody over her. Let me tell you — it was fucking awful. I don't think one of my brothers has ever recovered from it, or forgiven me. Our house was dead for ten years after. A happy kid for most of my life, even through my teenage year, I went on to struggle with extreme, oftentimes suicidal, depression for the rest of my twenties.



Borderline Personality Disorder

Borderline personality disorder (BPD) is a mental health condition in which a person has long-term patterns of unstable or turbulent emotions. These inner experiences often result in impulsive actions and chaotic relationships with other people.

Causes

Cause of borderline personality disorder is unknown. Genetic, family, and social factors are thought to play roles.

Risk factors for BPD include:

- Abandonment in childhood or adolescence
- Disrupted family life
- Poor communication in the family
- Sexual, physical, or emotional abuse

This personality disorder tends to occur more often in women and among hospitalized psychiatric patients.

Symptoms

Persons with BPD are often uncertain about their identity. As a result, their interests and values can change rapidly. They also tend to view things in terms of extremes, such as either all good or all bad. Their views of other people can change quickly. A person who is looked up to one day may be looked down on the next day. These suddenly shifting feelings often lead to intense and unstable relationships.

Other symptoms of BPD include:

- Intense fear of being abandoned
- Cannot tolerate being alone
- Frequent feelings of emptiness and boredom





Dear Judge Gordon-Oliver:


I write to request that the court address a subpoena that was served on my wife at my home on Friday afternoon by a process server hired by Stephen Russell. The document directed that I appear in court on Tuesday, August 6, 2019 to provide testimony at a hearing. I believe this subpoena is yet another effort to harass and threaten my family by Stephen Russell and his attorneys. On Friday, my wife was home when she turned around in the kitchen to observe a man on the back deck of the home. She was frightened and with our granddaughter Evelyn in her arms approached the door to inquire. The man (who I later learned was a process server hired by Stephen Russell) asked for me and when my wife advised I was not home he went back to his car parked in the rear of our property. He made a phone call and returned to the back deck, despite the fact my wife asked him to leave our property.

I ask that you address whether this was at all appropriate and that you dismiss the subpoena for my appearance. I do not believe it was right that without notice or cause an individual hired by Stephen Russell thinks it is okay to enter our property, walk onto the back deck, and not leave when asked to do so.

I ask that you direct Stephen Russell to seek court permission prior to sending a subpoena to me or any member of my family in the future because he does not act for appropriate reasons but to harass, threaten and intimidate. Also, serving me with a subpoena on Friday to appear in court for a hearing the following Tuesday is unjustified, especially when there is no hearing scheduled. He should not be able to use the court system in this way.

I am sorry to impose upon your time to deal with this but without court intervention I do not know any other reasonable way to deal with this. In addition, I was caused to go the emergency room on Saturday, admitted and I am currently hospitalized and unable to attend court on Tuesday. Thank you for your time.

During my time acting as nanny on March 30th, I observed a raised, red and clearly irritated rash on Evie's chin, hidden in her baby fat. Otherwise she seemed to be perfectly fine aside from having a ravenous hunger for the food we had for her. Both myself and the supervisor both noticed and discussed the rash and her hunger. On March 31st I acted as Nanny again and that day I observed a bruise on Evie's left shin as Steve was changing her diaper. The day before I did not see a bruise as he changed her but on March 31st it was very visible. The Supervisor made a note of it and said she had to make a report for it. Steve mentioned he would follow-up and give her a bath the next time to check for any other areas. On March 31st she had the same ravenous hunger but the rash was less noticeable than it was the day before.

At the drop off of Evie I witnessed Steve Walsh pull up at the top of the driveway after the supervisor headed toward the house with Evie, so the supervisor was not there to see this. Steve Walsh exited his car and had a rude attitude toward Steve and proceeded to say that he was "bringing his kids back home from school" on Sunday March 31st at approximately 5:30. Steve Russell did not respond and simply sat in the car to wait for the supervisor to return. Once the supervisor returned she asked if that was Tara's father behind us and Steve Russell confirmed and we drove off the property. Steve Russell remained calm throughout the entire interaction with Steve Walsh.
