1. In February 2018, Steve stopped giving Tara the promised financial support even though she was pregnant, on her way to a two-week job in Miami. He said she had no money to MI for support. After weeks of pleading with him, she agreed to move to MI as he promised her support from there. In MI, she made numerous attempts to return to NY, but was blocked by Steve, his security guards.
2. Since December 2018, baby's father has been acting psychotically, saying things that aren't true, believing he is being spied on (mostly by Russian government) and frequently was possessed by "spirits." Tara, his security guards, and his family believe he has schizophrenia induced psychosis. Father has history of abusing cocaine and alcohol.
